Expenses, associated with travel and accommodation of the conference nonresident participants, are to be paid by a sending organization.

Thesis requirements: MS Word, A-4 page size, font Times New Roman size 14, margins – 2,0 cm, line space 1,5. Number of pages - 5 pages maximum, numbering is at the center bottom. Article text alignment is in width without hyphenation; "..." quotation marks. It is necessary to provide the reference list,

consisting at least of three references, at the end of the article. The references are to be ordered as they are mentioned in the text. The references shall be organized in accordance with the GOST requirements.

The literature references shall be given in square brackets (example: [1], [1–5; 9]).

If the text comprises tables or figures, it is necessary to provide references to them (the tables and figures are to be located right after the first reference to them). All the tables and figures shall be named and numbered. The table name is to be provided above the table box on the left, and the figure name – at the center below the figure. The figures shall be prepared in the editors that are surely compatible with Word editor. Times New Roman 12 is allowed to use in the tables and figures.

«Bold» type and underlining shall not be used in the article text, italic type is allowed.

Thesis structure:

Article title (in bold type), initials, last name (in bold type), university, organization (in bold type), abstract and key words *in Russian and English*.

Thesis abstract shall comprise 50 words maximum; separated by blank lines; alignment – in width; single spacing; auto-indentation in the abstract and in the text («intended line») – 1.25 cm. *Key words:* words and phrases –10 maximum (see a sample below).

Authors are responsible for truthfulness of the actual material and data given in the articles, accuracy of citing and references to official documents and other sources. All the submitted articles are subject to checking through the «Antiplagiat» system. Minimum level of the text originality – 75 %.

Theses, that do not meet the requirements of the present publication conditions, will not be accepted.
